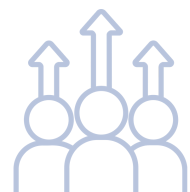

# 02 THE FRAMEWORK

This framework supports the supply of emergency medical consumables and equipment, providing an alternative route to market for NHS Ambulance Trusts and emergency services organisations.

Its core purpose is to support contracting authorities in building resilient supply chain options. Ambulance Trusts will continue to use NHS Supply Chain for clinical sundries as their primary route. This framework provides additional assurance when rationing, non-supply or wider supply chain disruption occurs. This approach helps organisations respond more quickly to supply risk and strengthens the NHS's ability to manage and mitigate disruption.

While the framework is primarily designed for NHS use, it also includes provisions that enable non-NHS organisations to access and benefit from it. This approach allows a organisations to leverage NHS buying power when securing clinical supplies and equipment.

An innovative product database underpins the framework, covering a broad range of consumables and equipment. It allows buyers to search flexibly using multiple fields, improving accessibility and speed of procurement.

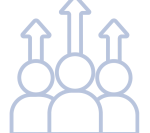

# FRAMEWORK OVERVIEW

This buyers' guide and mini competition document is intended to provide information about the [Emergency Medical Consumables and Equipment](#) framework and to provide practical support and documentation to contracting authorities who wish to procure products under the framework.

Please note, the guidance provided within this document applies only to this framework. Contracting authorities should ensure they refer to the specific guidance document relevant to any other framework agreement they wish to access to ensure that the right processes are being followed.

The framework has been set up for medical consumables and medical equipment to be costed on a price per banded price basis via utilisation of the framework database. Awards against this framework can be undertaken via two options:

OPTION 1:  
MINI COMPETITION

OPTION 2:  
DIRECT AWARD

The Emergency Medical Consumables and Equipment framework sets service specialisms relevant to the services to be delivered under each lot and core key characteristics and capabilities for supplier skills and abilities. See the EMCE database for full information on capabilities, suppliers and pricing.

Within the database you can search such fields as, Supplier, Category, GTIN number, Manufacture product code, Unit of Issue, NHS Supply Chain code, Size, Weight & Pricing.

It's envisaged that the database will reduce the amount of administration at contracting authority and supplier & will lead to more efficient communication as a result.

On the anniversary of the framework EoECPH will implement a CPI Indexation uplift within the database, so that contracting authorities will always have the framework price that's applicable. Please note that some suppliers have opted out of the CPI uplift.

# FRAMEWORK OVERVIEW

This framework agreement is delivered by NHS Commercial Alliance, a strategic partnership between NHS Commercial Solutions and the East of England NHS Collaborative Procurement Hub. The alliance provides specialised procurement solutions to all 14 ambulance trusts nationally through a dedicated membership model, strengthening consistency, resilience and buying power across ambulance services.

The framework was designed with small and medium-sized enterprises (SME's) in mind and has attracted twenty seven such organisation resulting in circa 77% of the framework being covered by SME Suppliers.

## THE BENEFITS OF THE FRAMEWORK ARE:

- ✓ The framework allows for access to manufacturers, distributors and wholesalers
- ✓ The framework agreement aligns with the Ambulance National Load List using categorisation
- ✓ The database contains relevant information to enable trusts to map direct product and equipment
- ✓ Equipment (Where appropriate) has secured the relevant Pre-Acquisition Questionnaire (PAQ Form) and will use the database to facilitate trusts gaining that document.
- ✓ Prices secured for 12-month period.
- ✓ CPI Indexation approach to pricing for remain term of the agreement.
- ✓ Capturing Scan4safety requirements from suppliers.
- ✓ Social Value & Sustainability commitments from suppliers.

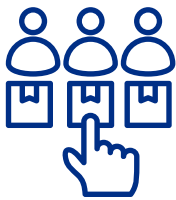

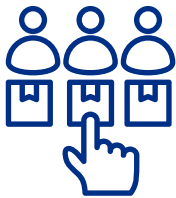

# PROCUREMENT PROCESS

We provide flexible, compliant options to secure services from the framework:

## MINI COMPETITION

- ✓ Publish your service specification to all eligible suppliers in the lot.
- ✓ Evaluate responses using criteria tailored to your local needs.
- ✓ Award the contract and obtain an order **code** for call-off references

## DIRECT AWARD

- ✓ Select the best value supplier based on:
  - framework information
  - available intelligence
- ✓ An efficient, compliant approach using pre-evaluated suppliers.



## TIPS FOR SUCCESS:

- 1 **Tailor your needs** Focus on your bespoke needs rather than capability checks (suppliers are pre-qualified).
- 2 **Provide information** Make sure to provide sufficient information to allow accurate responses.
- 3 **Share pricing** Share pricing with the Hub for due diligence before final award.
- 4 **Engage stakeholders** Engage with relevant stakeholder prior to going to out to tender (include early on in tender).
- 5 **Plan ahead** Allow sufficient time for a comprehensive submission.
- 6 **Pre-market engagement** Run pre-market engagement prior to issuing a tender.

# PROCUREMENT PROCESS

## IMPORTANT INFORMATION

This Hub framework is managed by the Ambulance and Training team. If you have any queries concerning the framework or competition requirements, please contact them via email at [ambulance@eocph.nhs.uk](mailto:ambulance@eocph.nhs.uk). We aim to respond to all queries within two working days of receipt.

- ✓ Terms and conditions have been issued for the framework; these should be incorporated into any call-off order contract awarded against the framework. Contracting authorities should not accept alternative terms offered by a supplier where they do not reference and accept the overarching requirements of the framework agreement.
- ✓ The call-off order provides additional information and can be found in the documentation provided. This form should be completed and signed off by both parties (the contracting authority and supplier) on award and a copy returned to [ambulance@eocph.nhs.uk](mailto:ambulance@eocph.nhs.uk). The Hub will issue an access code which must be included on all contractual documentation for compliance.
- ✓ Local specifications should not include or ask for information which is considered qualifying or references capability or eligibility requirements. The framework provides this assurance, mini competitions should focus on bespoke needs and the ability to deliver the services required.
- ✓ Contracting authorities should ensure questions asked in the mini competition are relevant to their local needs and requirement when mini competition is carried out.
- ✓ Please ensure you provide sufficient information to enable the suppliers to respond to your mini competition.
- ✓ The EMCE database is available to use in conjunction with the framework. It contains relevant banding price arrangements based on lots.
- ✓ The framework sets banded prices: 1 to 17 bands for lots 1, 2 and 3 and 1 to 9 for lot 4 which can be viewed in the EMCE database. Mini competitions can be run by the contracting authorities using the framework database price as a guide towards potential mini competition commercial offerings.

# PROCUREMENT PROCESS

## IMPORTANT INFORMATION

- ✓ The Hub will carry out due diligence on pricing submitted through mini competition on behalf of the contracting authority. Prices submitted under the framework are treated as commercially confidential and are not published to support fair competition and enable providers to offer their best prices through mini competitions. Please submit the mini competition's preferred bidder's prices to enable the due diligence to be carried out ahead of a supplier's award via email to [ambulance@eocph.nhs.uk](mailto:ambulance@eocph.nhs.uk).
- ✓ The scope of products and consumables are outlined in the Category List found at [page 25](#) of this buyers guide. If you require more information on a supplier's ability, such as clarification on their inclusion in Frameworks or to access case studies, please contact [ambulance@eocph.nhs.uk](mailto:ambulance@eocph.nhs.uk).
- ✓ This framework operates a KPI regime that was contained as a part of the procurement documentation and was specifically designed for the framework agreement. Contracting authorities can implement their own KPI regime as part of their call off arrangements.

# PROCUREMENT PROCESS

## MINI COMPETITION AND DIRECT AWARD

### ORDER CODE

Contracting authorities must obtain a unique order code after calling off from the framework. This code must be quoted on all correspondence, commercial documents and contractual paperwork issued to the supplier.

### MINI COMPETITIONS

Mini competition is the preferred procurement route as it provides transparency and helps ensure best value for money.

#### Process:

- ✓ The contracting authority publishes a service specification for the mini competition.
- ✓ All eligible suppliers must be invited to submit a response.
- ✓ Responses are evaluated using the criteria set out in the mini competition documents.
- ✓ The Hub provides governance and assurance on price per unit and contract costs submitted as part of the competition.
- ✓ When a contract is awarded and both parties have signed the call-off order, the contracting authority obtains an order code from their procurement support supplier or from the Hub.

Contracting authorities may tailor or refine the evaluation criteria when re-opening competition to reflect local priorities.



#### EXAMPLE:

EoECPH are able to support with the provision of templates to enable you to run a Mini Competition, however you are also able to utilise your own internal templates.

All eligible Suppliers are invited to submit responses which are evaluated using predefined criteria outlined in the Mini Competition documents. During a Mini Competition, a Buyer may tailor the evaluation criteria to address specific local needs, ensuring maximum value for both the organisation and the community.

Upon awarding a contract, the Buyer must obtain an access code from EoECPH, which is needed once both parties sign the call-off order.

# PROCUREMENT PROCESS

The mini competition documents include drafting notes **DN [TEXT ENTERED BY WAY OF INFORMATION]**. These are to be deleted as you complete the tender with your local bespoke needs and should not to be left in at the point you issue the mini competition to suppliers.

## DIRECT AWARD

Direct award without mini competition is permissible where the contracting authority can clearly demonstrate best value for money from a single supplier.

This may be evidenced through:

- ✓ Framework information
- ✓ The EMCE database
- ✓ Supplier websites
- ✓ Market intelligence
- ✓ Other credible sources of information

Direct award should only be used when the requirement and the market make the selection of the supplier clear and justified.

While supplier pricing remains commercial-in-confidence and is not published in framework documentation, it is available on request to support contracting decisions.

# TEMPLATES

Base templates for a mini competition under this framework are included within the document set. Please ensure all yellow highlighted drafting areas/notes are completed and deleted where necessary prior to publication.

Once the mini competition process is complete, you should communicate your decisions to suppliers who have submitted bids.

The use of these templates is not mandatory for mini competitions under this framework and contracting authorities are able to use their own documents.

## MINI COMPETITION (EVALUATION CRITERIA AND TEMPLATE DOCUMENTS)



When a contracting authority wishes to undertake a mini competition, they have the option to review the evaluation criteria against their local needs and update certain elements as required.

The evaluation criteria can be amended at mini competition stage and emphasis can be placed onto areas which best reflects the contracting authority's needs or business objectives. Where no special emphasis is needed, the weighting and sub-criteria can remain unchanged.

### GENERIC MINI COMPETITION EVALUATION HEADINGS FOR LOCAL CONTEXT:

1

**Social value**

**10%, or as detailed by the contracting authority**

- ✓ Climate change (framework level)
- ✓ Economic inequality (framework level)

2

**Quality**

**60%, or as detailed by the contracting authority**

- ✓ Approach to local delivery for the contracting authority
- ✓ Planning, transition and implementation

3

**Commercial**

**30%, or as detailed by the contracting authority**

- ✓ Cost and competitiveness (cost per unit).

Contracting authorities have flexibility to adjust the components and weightings under the broad evaluation headings to reflect their local requirements. For example, they may choose to focus heavily on a particular criterion, such as commercial or quality assurance. However, social value must always carry a minimum weighting of 10% in the evaluation to ensure this factor is considered in every procurement.

# TEMPLATES

## CALL-OFF ORDER CONTRACT TERM

Please ensure you use the call-off order contract template and terms and conditions provided in the document set to secure services under this framework for both mini competition and direct award. As noted within the framework agreement, alternative terms and conditions may be used where both parties agree. Examples of some differing terms and conditions can be found within the framework agreement. Where different terms and conditions are utilised, these must be detailed within the order form.



### IMPORTANT NOTE:

Once a call-off contract is signed by both parties, request a unique order code from the Hub. Returning a fully signed call-off order to [ambulance@eocph.nhs.uk](mailto:ambulance@eocph.nhs.uk) ensures your contract is officially recognised and allows you to:

- Legally call off services under the framework
- Quote the order code on all correspondence and commercial documents
- Benefit from framework governance and support throughout the contract

# ETHICAL COMMITMENTS

## MODERN SLAVERY

A modern slavery risk assessment was undertaken at framework level and the overall risk has been assessed as **medium**.

## SOCIAL VALUE

Social Value has been embedded at framework level in line with PPN 06/20, with a 10% qualitative weighting applied to the overall quality score, in accordance with government policy and NHS requirements.

Two Social Value themes have been applied to this framework, reflecting the nature of consultancy and transformation services and the way social value can be delivered proportionately through service delivery models rather than core outputs.

### THEME 2: TACKLING ECONOMIC INEQUALITY

Theme 2: Tackling Economic Inequality has been applied, with a focus on:

MAC2.2: Create employment and training opportunities particularly for those who face barriers to employment and/or who are located in deprived areas, and for people in industries with known skills shortages or in high growth sectors.

MAC 3.4: Demonstrate collaboration throughout the supply chain, and a fair and responsible approach to working with supply chain partners in delivery of the contract.

## NET ZERO AND CARBON REDUCTION COMMITMENTS

As part of the framework establishment process, suppliers were required to provide a Carbon Reduction Plan in line with PPN 06/21.

In addition to providing a carbon reduction plan, suppliers asked to start and undertake an Evergreen maturity assessment.
